

REGISTRATION RULES 2014

(1) The registration of an entrant and/or driver for the series shall have to be available with the TMG GT86 Cup Organisation by 18:00 h prior to the respective event at the latest.

The application for registration shall have to be sent to TMG GT86 Cup Organisation:

or shall have to be handed in to the technology truck.

(2) Registration fee of participant:

The registration fee per vehicle shall amount to EUR 4,500.00 plus legal value-added tax and shall have to be paid by bank transfer to the organisation TMG GT86 Cup/IKmedia GmbH three days after receipt of invoice.

After receipt of the first driver's registration and nomination of the entrant, an invoice to the amount of EUR 4,500.00 plus legal value-added tax will be sent to the respective entrant.

The registration fee paid shall permit the participation in the TMG GT86 Cup within the framework of the VLN.

(3) If an entrant and/or driver does not participate in the series despite registration, the registration fee shall not be reimbursed.

(4) If more applications for registration are received by TMG GT86 Cup Organisation than free places in the TMG GT86 Cup are available (the order of receipt of the application shall be decisive), TMG GT86 Cup Organisation reserves the right to choose the entrant and/or driver.

(5) TMG GT86 Cup Organisation reserves the right to not accept drivers, whose registrations have been confirmed, to individual events of the TMG GT86 Cup stating reasons. Moreover TMG GT86 Cup Organisation reserves the right to refuse applications for registration without stating reasons.

(6) If less than five registered vehicles participate in the TMG GT86 Cup, neither points or prizes will be awarded.

(7) Sponsors or other companies which shall appear in official announcements of the organiser (programme leaflet, result lists, press releases, et cetera) in conjunction with the entrant and/or driver may achieve this by purchasing a DMSB sponsor licence and a corresponding note on the registration form.

(8) Registered entrants and/or drivers who withdraw from the TMG GT86 Cup before the end of the season shall not be entitled to a refund of the proportionate registration fee. The fee shall not be refunded either, if the resignation has been caused by a written request of TMG GT86 Cup Organisation or a sports-law decision of DMSB renders participation impossible.

The registration fee of entrant and/or driver shall not be refunded either in case of non-participation in individual events or their cancellation.

(9) The entrant and/or driver shall be obligated to include to the registration a copy of the entrant and/or driver's licence, a copy of the binding race car appointment as well as the completed questionnaire and the exclusion of liability. Application without the corresponding enclosures cannot be processed.

(10) All data rendered in the questionnaire may be published without restrictions by TMG GT86 Cup Organisation on their website www.gt86-cup.com.

(11) With a valid registration to the TMG GT86 Cup 2014, the new vehicle price shall amount to EUR 38,500.00 plus legal value-added tax. Without a valid registration to the TMG GT86 Cup 2014, the new vehicle price shall amount to EUR 42,500.00 plus legal value-added tax.
